Pursuant to Article 133, paragraph 4 of the Air Transport Law ("Official Gazette of RS", No. 73/2010, 57/2011, 93/2012, 45/2015, 66/2015 - other law, 83/2018 and 9 / 2020, Article 4, paragraph 1 and Article 7, paragraphs 3 and 4 of the Rulebook on Airport Charges ("Official Gazette of RS", No. 71/2013, 48/2016 and 96/2017) and Article 16 of the Decision on the incorporation of the company number GD-3996/2019 dated 22 July 2019 - clean text, Chief Executive Officer of the company BELGRADE AIRPORT d.o.o. Beograd, 11180 Belgrade - Surčin, st. Aerodrom Beograd no.47, Republic of Serbia, (hereinafter: the Company) on 31/10/2022 adopts the following:

DECISION on changes in the amount of airport charges

1. A segment of airport charges i.e. the amount thereof is changed, as follows: charges for airport services from sub-item 1) of this decision, charges for special services provided to passengers - passenger service from sub-item 2) and charges for use of BRS system from sub-item 3) of this decision, whereby new charges, presented in new price lists, amount to:

Note:

- Prices are expressed excluding VAT, for RS residents the calculation is conducted at the official middle exchange rate of the NBS valid on the day of the tax liability.
- The price for the use of Centralized Infrastructure represents the calculated amount per MTOW of the aircraft.
- For services provided in the period from 22.00 - 05.00, the price for the use of Centralized infrastructure increases by 30%, except for cargo aircraft flights
- The price for the use of air bridge represents the calculated amount per MTOW of the aircraft. The price for the use of air bridge represents the price for the arrival and departure of an aircraft. If the air bridge is used only in one direction, the price is calculated as 50% of the stated amount.
- Landing and Lighting price represents the calculated amount per MTOW of the aircraft.
- Lighting service is calculated according to the period of sunset / sunrise,
- The price of parking represents the calculated amount per ton for 24 hours. There is no charge for parking up to 4 hours.

2. This Decision shall enter into force on 1 January 2023, when the application of new airport fees shall commence, i.e. the implementation of price lists from item 1. sub-item 1), 2) and 3) hereof.
3. On the day of entry into force and application of this Decision, in accordance with the Decision on taking over general acts of JSC Airport "Nikola Tesla" Belgrade on the Concession commencement date, number 225-11-9-12 / 2018 dated 21/12/2018, the following Price lists shall be revoked:
- Price list of airport services, number GD-4104/2022 dated 31/10/2022
 - Price list of special services for passengers - passenger service and security charges, number GD-4105/2022 dated 31/10/2022, except in the part defining the security charge which shall remain in force and continue to apply;
 - Price list of use of BRS system, no 05-237-2 dated 09/07/2015

4. This Decision shall be published on the notice board and on the Company's website.
5. OU Commercial affairs and marketing is hereby authorized for the implementation of this decision.

Explanation

In accordance with article 7 of the Rulebook on Airport Charges of the Republic of Serbia ("Official Gazette of the RS", No. 71/2013, 48/2016, 96/2017) (hereinafter: the Rulebook), and in connection with Article 133 of the Air Transport Law of the Republic of Serbia ("Official Gazette of the RS", No. 73/2010, 57/2011, 93/2012, 45/2015, 66/2015 - other law, 83/2018 and 9/2020), BELGRADE AIRPORT d.o.o. Belgrade started the process of consultations with the airport users on August 31, 2022, by submitting an official proposal to change the amount of airport charges for year 2023 (Revision of Airport Charges-Proposal for Adjustment of Airport Charges for the year 2023) to all airport users, with the announcement of their increase and grounds with detailed clarification for proposing the changes (Belgrade Airport doo Beograd letter no. GD -561 dated 31/08/2022).

The proposed changes include fees for airport services, as stated in the enacting clause/wording of this decision (use of centralized infrastructure, air bridge, landing, aircraft parking, CUTE, PSC and BRS), and the amount of each of these mentioned fees increases according to the following model:

- Passenger Service Charge:
 - International Local Departing passengers: increase by 2,25 euros
 - Transfer passengers: no increase
 - Domestic passengers: no increase
- All other Airport charges encompassed in:
 - Price List of Airport Services;
 - Price list of special services for passengers (excluding security fee);
 - Price list of use of BRS system,

: 6.5% increase

The consultation process was completed by September 15, 2022.

Until the end of the consultation process, that is, until the date of adoption of this Decision, there were no comments/remarks received from the Committee of Air Carriers, i.e. airport users on the proposed change in the amount of airport charges.

Hereof decision was adopted with strict adherence to legal and regulatory obligations, comments and remarks presented by airport users during the consultation process as well as in regard to the impact of these changes on all participants.

Charges have been set on a non-discriminatory basis, with relevant, objective and transparent criteria.

Considering all above stated, it has been decided as in the wording of the Decision.
