Pursuant to Law on Obligations and the Basics of Property Relations in Air Transport ("Official Gazette of RS", No. 87/11 and 66/22015), Article 43, and Article 16 of the Decision on the incorporation of the company number GD-514/2024 dated 04 March 2024 - clean text, Chief Executive Officer of the company BELGRADE AIRPORT d.o.o. Beograd, 11180, Belgrade 59, Belgrade - Surčin, Republic of Serbia, (hereinafter: the Company) on 31.10.2024 adopts the following:

DECISION on changes in the amount of the PRM charge

1. Hereby, the following is subject to change: the amount of the PRM charge of this decision is changed so that the new charges, shown in the new price list, shall amount to:

- Price includes VAT
- Calculation for payment will be made as the official middle exchange rate of NBS valid on the date of payment.
- From this payment are exempted: ID00, unaccompanied minors, crew, transit and transfer passengers



- 2. This decision enters into force and applies from 01.01.2025, when the application of the new PRM charge, i.e. the price list from point 1 of this decision, will begin.
- 3. On the date of entry into force and the start of application of this decision, the application of the Price list of PRM charge, number Pricelist of PRM service 05-238/2015 dated 09.07.2015, is put out of force.
- 4. Publish this decision on the bulletin board and the Company's website 31.10.2024.
- The OU Commercial Business and Marketing is responsible for the implementation of this decision.

Explanation

Pursuant to Law on Obligations and the Basics of Property Relations in Air Transport ("Official Gazette of RS", No. 87/11 and 66/22015), Article 43, BELGRADE AIRPORT d.o.o. Belgrade started the process of consultations with the airport users on October 11, 2024, by submitting an official proposal to change the amount of security charge applicable as of January 01, 2025 (Notice of Proposal on Adjustment of PRM Charge) to all airport users, with the announcement of its increase and grounds for proposing the changes and clarification of changes proposed, letter no. GD -2140/2024 dated 11/10/2024).

At the Airport Operators Council / AOC meeting held on October 18, 2024, the Airport Operators Council / AOC agreed to the proposal of BELGRADE AIRPORT d.o.o. Belgrade, the consultation period regarding the changes in connection with the PRM change amount lasts until October 31, 2024. (Minutes from the AOC meeting from October 18, 2024, attached here).

Belgrade Airport proposed a 0,15 euro increase in the current model for PRM charges for arriving and departing passengers, effective as of January 01, 2025. The new charge of 0,74 euros per departing passenger has been fixed to obtain a zero Net Result over 2024 and 2025. The revision of PRM charge also included a charge of model for charging, from 1st January 2025, PRM charge will be collected only from departing passengers to enable operational simplification. Instead of the current 0,44 euro for the round trip (total invoiced to dep and arriving passengers), the new PRM charge will be 0,74 euro/dep pax, including VAT.

From this payment, ID00, unaccompanied minors, transit passengers, and transfer passengers are exempted.

This adjustment is essential to meet the rising costs of maintaining and improving and adequate level of PRM services at Nikola Tesla Airport in Belgrade. Belgrade Airport has conducted a comprehensive analysis to ensure that this increase is reasonable and necessary to sustain our operations at the highest levels of organizational effectiveness and efficiency.



The consultation process with airport users was completed on October 31, 2024.

During the process of consultations with air carriers and received comments/suggestions, there were no objections to the submitted Price List proposal.

This decision was made with full respect for legal and regulatory obligations, comments and objections expressed by airport users during the consultation process, and the impact of these changes on all participants.

Charge is set on a non-discriminatory basis, with relevant, objective, and transparent criteria.

Taking into account all the above, it was decided as in the enacting clause.
